

1335.

Manor of BENSTEDE (DROXFORD Parish)

(Calendar of Patent Rolls – 18<sup>th</sup> April 1335).

GRANT (by King Edward III) to (his) Queen PHILIPPA of the custody, during the minority of the heir (aged 3), of the lands late of JOHN DE SEINTCLER, tenant in chief, with the issue from the day of the death of the said JOHN and the marriage of the heir (i.e. JOHN's son JOHN).

Manor of BENSTEDE (in DROXFORD Parish) - 1335

"Extent" drawn up on inquisition post mortem of JOHN DE SE(Y)N(T)CLER – 4<sup>th</sup> July, 9<sup>th</sup> Edward III. (PUBLIC RECORD OFFICE – ref. C135/44).

Inquisition made at WINCHESTER by WILLIAM DE NORTHO, escheator to the King in county of Hampshire ... of Peter DE PERESHUTTE (?), Lawrence ATTE MULLE, Peter SHELYDE, John DAWGHE, Henry LE WHITE, John LE BOLE, William DE MYDLINGTON, Henry WHREY, Peter MAYSAUNT, John BORYE, William ATTE BROKE and Thomas LE FOREST (jurors) ... regarding the manor of BENSTEDE held, jointly with ALICE his wife, who still survives, by fine levied in the King's court, of JOHN DE SCURES, knight, by service of one knight's fee (the heir is JOHN, son of said JOHN and ALICE DE SE(Y)N(T)CLER, aged three years and more ... finds there one capital messuage valued at NOTHING each year after repairs; one garden of 2 acres in which there is no fruit on account of the dryness of the trees but the pasture of this is worth 18d. per year; one water-mill valued per year (apart from repairs) at 13s. 4d.; 120 acres of arable land valued at 50s. per year (60 acres at 6d. per acre and the other 60 acres at 4d. per acre); 8 acres of meadow worth 10s. 8d. per year (16d. per acre); 16 acres of separate pasture worth 4s. per year (3d. per acre); pasture for 60 two-year-old sheep, in separate pieces, worth 40d. per year; dense woodland of 2 acres, with pannage, worth 2s. when available, then in Autumn worth 12d. and the pasture of the same worth 6d. per year; assize rents from cottars 13s. 4d. due at the 4 terms of the year in equal portions, that is to say, of five [COTTERELL']; and there is owing from them two days at the Autumn harvest, either the Lord's wheat or oats, and there is valued in all at 20d., price for the work of each 4d.; the pleas and perquisites of court worth 12d. per year.

HUNDRED OF WALTHAM.

"The Bishop of WINTON holds the manor of WALTHAM and all his other lands "spectantes" to the said bishopric, and all lands which the Prior of Saint Swithin at WINTON holds in the said county (i.e. Hants), by 5 (knights') fees.

PHILIPPA, Queen of England, holds half a (knight's) fee in BENSTEDE and HALLIWELL by reason of her custody of JOHN SEYNTCLER, from which same half fee ("medietate feodi") NICHOLAS DE LA BERE holds a twentieth part".

# FROM A CHARTER OF EDWARD III (A.D. 1349) RE. ST. GILES FAIR, WINCHESTER (ed. G.W. KITCHIN, D.D.).

"And very many of the Bishop's tenants, who hold lands and tenements of him by service of making suit at the Pavilion\*, are bound to come and shall come thither on each Vigil of St. Giles, before 6 in the morning, to make their suit of service at the Pavilion, and shall be prepared with horses and arms as often as may be needful. From among them the Justiciaries shall, at their pleasure, select 3 or 4 (or more or fewer, as they may see it will be needful) to serve and tarry in the Fair during its continuance, and to carry out the executions and precepts of the said Justiciaries in all places within the 7 leagues, and at Southampton, as often as shall be needful for the safeguard of the peace and the Fair, and this at the wonted charges of the Bishop".

(\* PAVILION COURT/HALL stood on St. Giles Hill (now "Palm Hall" – tent in which the Bishop's Justiciaries dispensed (well-nigh) summary justice in all cases during the Fair from the Fair itself and from any place within the 7 league circuit on any local or stranger).

INDENTURE made at MIDDLINGTON on this date Between WILLIAM DE HULHAMPTON and CECILY his wife, JOHN DE RUMSEY and JOHANNA his wife and JOHN DE GARTON and JOHANNA his wife, Being a Final Division of all the Lands, Tenements, Curtilages, Gardens, and Dovehouses, and the Rents and Services, as well of free Tenants, as of Bondmen, Reliefs, Wards, Marriages, Escheats, Mills, Waters, Fisheries, Meadows, Feedings, Pastures, Woods, Underwoods, Quick Hedges, Rows, with all other the Appurtenances not named in the VILLAGES of MIDDLINGTON, HILL, LOMER, SWANMORE, SOBERTON and PRESHAW.

To the said WILLIAM DE H., JOHN DE G.,

After the death of ALICE, Daughter and Heir of RICHARD DE MIDDLINGTON

As the Right of the said CECILY, JOHANNA and JOHANNA, Cousins and next Heirs of the said ALICE, Now Assigned to and with the Consent of the Parties,

By certain honest Men of the Neighbours, thereunto specially required to be personally present. WHEREBY amongst other lands, Tenements, and Hereditaments;

The Fishery of the River at MIDDLINGTON, and the Pasture there being for Beasts, Sheep and Hogs, and the Amerciaments and Issues of the Courts of the Same; And Common of Pasture for one bull and twelve beasts, going in the Woods of the BISHOP OF WINCHESTER;

And for One Boar and twelve Hogs, going in all the Places there, within the Manor of DROXFORD; And Pasture for One Hundred and one Sheep, going in all the Places there, in the Manor of the said BISHOP;

And also Common in the Woods of the said BISHOP, called HORDERSWOOD,

Was Assigned to the said Parties, and confirmed by Fine levied in the Court of our SOVEREIGN LORD THE KING;

A Part of which Indenture was then delivered to each of the Parties, and attested by NICHOLAS DE LA BEERE, ROGER DE INGEFIELD, THOMAS SWERARD, JOHN DAWE, HENRY SIMBER, ROBERT LE CLERKE, JOHN ATTA DALRE, and divers others; dated at MIDLINGTON 12 May, Anno Regni EDW (DI), 3 (LII), 20'.

Inquisition post mortem at Winchester on 24 July in 50 Edward III re. JOHN DE GARTON of EREHITHE, citizen of London, deceased, mentions:-

"MIDDELTON: A toft, 25 acres arable, 1 acre meadow, 3.5 acres woodland and 19 shillings rents, held of the Bishop of Winchester, as of his manor of DROKENESFORD, in right of his church, by service of a third part of 32s. 8d. yearly rent and a third part of a quarter of wheat yearly called 'cherchet' and also by ploughing a third part of 4 acres of land as 'beynhurth' and giving pannage of pigs for his men".
