DROXFORD Church - the East window is built.

Farmhouse, St. Clair's Farm: timber-framed; brick infilling (O.S. 605154). (Reputedly a tunnel to here from DROXFORD MANOR HOUSE – some evidence of this found when workmen repaired the Manor House boundary wall about 10 yards west of the Churchyard gates). Existence of 2-storey medieval stone building discovered 1977/1978 (incorporated as S/E quarter of existing farmhouse).

#### 1597

Droxford Manor House (Hants C.R.O., 155642, pp. 22 et seq.)

8<sup>th</sup> July 1597: Lease of various manors from the Bishop to Queen Elizabeth, including the site of the manor of Droxford as defined in Lease from Bishop Gardiner to Philip BENSTED of Droxford, yeoman, 27<sup>th</sup> July 1554 (excepting advowson, rents of assize, courts etc.).

N.B. The Bensted family had held the Lease of the Demesne Lands since at least the early 1500's (per Bishopric Pipe Rolls).

It is clear from the Pipe Rolls that the BENSTED Family continued as farmers of Droxford and lessees of the site of the Manor until 1617 (ref. 155944).

# 7<sup>th</sup> October and 5<sup>th</sup> November 1597

JOHN FRYE (7<sup>th</sup> October), yeoman, of Droxford 40 years, native of Froxfield, age 67 and THOMAS FRY, husbandman, of Weston (Southampton) since Trinity, native of Droxford, age 29 (5<sup>th</sup> November), both deponents in Consistory Court cause of – REVES v. REVES alias FRYER (re. Will of GREGORY REVES).

## 1599

DROXFORD Church - the Tower (with stair-turret) is built (or re-built). (Reign of Queen Elizabeth I).

NOTE: In an Inventory of Church goods at Droxford made 15<sup>th</sup> July 1552 (Public Record Office) is included " ... Foure belles in the Steple ... ". (Therefore, perhaps the tower was first capped by a steeple and extended as a tower in 1599). ("Memorabilia").
